## PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL  
RETAIL PRICE FOR ILLUMINATING PARAFFIN

1. I, Mr. G. Mantashe, Minister of Mineral Resources and Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of every month.
2. The single maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 01 July 2020 to 04 August 2020 will be 882.0 c/l.
3. **Commencement**  
These regulations shall come into operation at 00:01 on 01 July 2020
