(ACT NO. 6 OF 1995)****GENERAL NOTICE****GOVERNING BODY REGULATIONS FOR PUBLIC SCHOOLS, 1997**

The Member of the Executive Council for Education and Youth has under section 31, read with sections 27(5), 28(3), 28(4) and 106, of the Gauteng School Education Act, 1995 (Act No. 6 of 1995), made amendments to the Governing Body Regulations for Public Schools, 1997, as contained in the Schedule.

**Amendment of regulation 1 of Regulations**

1. Regulation 1 of the Governing Body Regulations for Public Schools, 1997 (hereinafter referred to as the "Regulations") is hereby amended—

- (a) by the substitution for sub-regulation (1) of the following sub-regulation:  
"(1) Subject to sub-regulation (2) and unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Act shall have the same meaning in these **[regulations]**Regulations.";
- (b) by the substitution in sub-regulation (2) for the words preceding the definition of "catchment area" of the following words:  
"(2) In these **[regulations]**Regulations, unless the context indicates otherwise—";
- (c) by the insertion before the definition of "catchment area" of the following definitions, respectively:  
**"accredited external observer"** means a person (natural or juristic) that is authorised by the Head of Department to observe the election process of a school governing body in a public school;  
**"appropriate field"** means a field of special needs education which is appropriate to a school for special education;"

- (d) by deletion of the definition of "**catchment area**";
- (e) by the insertion after the definition of "catchment area" of the following definition:  
"category of disability" means a category of disability manifested amongst learners enrolled at a school for special education;
- (f) by the insertion after the definition of "days" of the following definition:  
"educator" means any person, excluding a person who is appointed to exclusively perform extracurricular duties, who teaches, educates or trains other persons or who provides professional educational services, including professional therapy and education psychological services, at school;
- (g) by the insertion after definition of "educator member" of the following definition:  
"e-Election" means a mode of election that is conducted electronically through virtual platforms;
- (h) by the substitution of the definition of "member of the community" of the following definition:  
"member of the community" means any person resident in the [catchment area]feeder zone of the school, any person whose place of work is in the [catchment area]feeder zone of the school, or any [alumnus]former learner of the school;
- (i) by the insertion after the definition of "member of the community" of the following definition:  
"minor" means a person who is below or under the age of 18 years old;
- (j) by the insertion after the definition of "non-teaching member" of the following definition:  
"online election system" means the hardware, software and processes which use electronic means to make a choice between options in an election; and
- (k) by the insertion after the definition of "ordinary school" of the following definitions, respectively:  
"organisations of persons with disabilities" means civil society organisations where the majority of members of staff, volunteers and members are persons with disabilities, and the organisation is controlled and managed by persons with disabilities;  
"parent" means—  
 (a) the biological or adoptive parent or legal guardian of a learner;  
 (b) the person who is entitled to legal custody of a learner; or  
 (c) the person who undertakes to fulfil the obligations of a person referred to in paragraphs (a) and (b) towards the learner's education at school;

### Substitution of regulation 2 of Regulations

2. The following regulation is hereby substituted for regulation 2 of the Regulations—

#### **2. Application of [regulations]Regulations**

These **[regulations shall]Regulations** apply to governing bodies of public schools within the Province."

**Amendment of regulation 3 of Regulations**

3. Regulation 3 of the Regulations is hereby amended by the substitution for words preceding paragraph (a) of the following words:

"The following principles **[shall]** underpin the governance of schools in the **[province]Province—**".

**Amendment of regulation 7 of Regulations**

4. Regulation 7 of the Regulations is hereby amended—

(a) by the substitution in sub-regulation (1) for paragraph (c) of the following paragraph:

"(c) representatives of organisations of **[disabled]** persons with disabilities, if applicable;"; and

(b) by the substitution of sub-regulation (3) of the following sub-regulation:

**"(3) [The Member of the Executive Council shall by notice in the Provincial Gazette determine the number of members in each category referred to in sub-regulation (1)](a) The Member of the Executive Council must, within 30 days of commencement of these Regulations, and after consultation with a governing body of a school for learners with special education needs, determine in respect of that school, the number of—**

**(i) categories of disability; and**

**(ii) appropriate fields.**

**(b) The total number of members in the categories contemplated in paragraphs (a) to (e) of sub-regulation (1) must be at least one less than the total number of members contemplated in regulations 4, 5 and 6.**

**(c) A governing body of a school for learners with special education needs must not be deemed to be improperly constituted if it is not reasonably practicable that a member in the categories contemplated in paragraphs (a) to (e) of sub-regulation (1) be so elected.**"

**Insertion of regulations 7A, 7B, 7C, 7D and 7E into Regulations**

5. The following regulations are hereby inserted after regulation 7 of the Regulations:

**"7A. Appointment of members in school for learners with special education needs**

**(1) An organisation may, in terms of paragraphs (b) or (c) of regulation 7(1), apply in writing to the Member of the Executive Council, within 30 days of commencement of these Regulations, to be represented in the governing body of a school for learners with special education needs.**

**(2) An application contemplated in regulation 7(1) and Schedule EB, must set out the reasons why the organisation believes it must be represented on the governing body of the school for learners with special education needs concerned. Schedule EA will be used to assess the application.**

**(3) Subject to regulation 7, the Member of the Executive Council must, within 30 days after the expiry of the period for applications contemplated in sub-regulation (1), and after consultation**

with a governing body of the school for learners with special education needs concerned, grant or refuse the application in terms of Schedule EC.

(4) If the Member of the Executive Council refuses an application in terms of sub-regulation (3), the Member of the Executive Council must provide the applicant organisation with written reasons for doing so.

(5) If the Member of the Executive Council grants an application in terms of sub-regulation (3), the applicant organisation must be entitled to appoint its own representative on a governing body of the school for learners with special education needs concerned in accordance with its own internal procedures.

(6) After the appointment of a representative contemplated in sub-regulation (5)—

(a) the organisation must notify the principal in writing of the name of the representative appointed to the governing body of the school for learners with special education needs concerned; and

(b) the principal must notify the district electoral officer in writing of the name of that representative.

(7) A representative of the organisation who is appointed in these categories into the governing body for learners with special education needs concerned has voting rights.

## **7B Nomination of sponsoring bodies, persons with disabilities and experts in schools for learners with special education needs**

(1) If there is a vacancy in a governing body of a school for learners with special education needs in respect of any category of disability or appropriate field, a member of the governing body may nominate a person in that category or field for election as a member of the governing body, as contemplated in regulation 7(1)(a), (d) or (e), by—

(a) lodging a nomination form with the principal not more than seven days and not less than one day before an ordinary meeting of the governing body, which form must be duly completed by the proposer and the candidate; or

(b) proposing a person as a member during the meeting contemplated in paragraph (a) and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate.

(2) At the meeting contemplated in sub-regulation (1), the Chairperson must—

(a) notify the members of the governing body of the nomination or nominations;

(b) inform the members that an election will take place at the next ordinary meeting of the governing body; and

(c) invite the members to nominate additional candidates for election in accordance with the provisions of sub-regulation (3).

(3) A member may nominate an additional candidate for election by—

- (a) lodging a nomination form with the principal not more than seven days and not less than one day before the next ordinary meeting following the meeting contemplated in sub-regulation (1), which form must be duly completed by the proposer and the candidate;  
or
- (b) proposing a person as a member during the next ordinary meeting following the meeting contemplated in sub-regulation (1) and lodging with the Chairperson a nomination form duly completed by the proposer and the candidate.

**7C The sponsorship bodies, persons with disabilities' members and expert members in schools for learners with special education needs:**

(1) At the next ordinary meeting following the meeting contemplated in regulation 9(2), the members of the governing body of a school for learners with special education needs with voting rights must, by secret ballot and in separate rounds of voting, in respect of relevant category of disability or appropriate field, elect one member from the validly nominated candidates for the sponsoring body, relevant category of disability or appropriate field.

(2) Every voting member of the governing body is entitled to vote and has one vote in respect of each candidate, with a maximum number of votes equal to the number of members to be elected in each round of voting.

(3) After the election of members contemplated in sub-regulation (2)—

- (a) the principal must notify each elected member in writing of that member's election as a member of the governing body;
- (b) the principal must notify the district electoral officer in writing of the name of each elected member; and
- (c) members elected in categories as contemplated in regulation 7(1) (a), (d) and (e) into the governing body do not have voting rights.

**7D Filling of vacancies by organisations in schools for learners with special education needs**

(1) If at any time after the expiry of the period contemplated in regulation (3), taking into account the number of members already appointed and the number of categories and fields determined in line with regulation 7(2)(a) and (b), regulation 7(3)(a) permits the election of further members to the governing body of a school for learners with special education needs.

(2) An organisation may apply in writing to the Member of the Executive Council to be represented in the governing body of a school for learners with special education needs, in terms of paragraph (b) and (c) of regulation 7(1).

(3) An application contemplated in sub-regulation (1) and Schedule EB must set out the reasons why the organisation believes it must be represented in the governing body of a school for learners

with special education needs concerned. Schedule EA will be used to assess the application.

(4) Subject to regulation 7(3)(a), the Member of the Executive Council must within 30 days after the expiry of the period of applications contemplated in sub-regulation (1) and after consultation with the governing body of a school for learners with special education needs concerned, grant or refuse application in terms of Schedule EC.

### **7E Composition of governing bodies of child and youth care centres and hospital schools**

A governing body of a child or youth care centre, or a hospital school, must be represented by members of the staff at the institution after nomination and election meetings in consultation with the electoral officer."

### **Amendment of regulation 9 of Regulations**

6. Regulation 9 of the Regulations is hereby amended—

(a) by the substitution of sub-regulation (1) of the following sub-regulation:

"(1) A governing body may at any time during its term of office, in accordance with the procedure set out in regulations 28 and 29, co-opt a member or members of the community with the relevant expertise to assist in discharging its functions: Provided that the number of co-opted members of a governing body at any time may not exceed three.";

(b) by the substitution of sub-regulation (4) of the following sub-regulation:

"(4) If a governing body of a school acts under sub-regulation (3), and if there is more than one owner of the property on which the school is situated, such owners **[shall]must** nominate **[one of their number members, or]** a representative, to represent them on such governing body."

### **Amendment of regulation 10 of Regulations**

7. Regulation 10 of the Regulations is hereby amended—

(a) by the substitution for sub-regulation (1) of the following sub-regulation:

"(1) The Member of the Executive Council may, by notice in the **[Provincial]Provincial Gazette**, determine that the governance of two or more schools [shall]must vest in a single governing body in terms of section 17 of the South African Schools Act, 1996 (Act No. 84 of 1996), if it is in the best interest of education at the schools in question."

(b) by the substitution in sub-regulation (3) for paragraph (a) of the following paragraph:

"(a) given notice in the **[Provincial]Provincial Gazette** of his or her intention so to act."

(c) by the substitution for sub-regulations (14) and (15) of the following sub-regulations, respectively:

"(14) The governing body established in **[subregulation]sub-regulation** (5) must be subject to all rules and regulations applicable to governing bodies.

(15) A quorum for any meeting of the combined governing body **[will be one half]**must be 50%+1 of the members representing each of the separate schools."

#### **Amendment of regulation 11 of Regulations**

8. Regulation 11 of the Regulations is hereby amended by the substitution for sub-regulations (1), (2) and (3) of the following sub-regulations, respectively:

"(1) Subject to sub-regulation (3), no act of a governing body **[shall be]**is invalid merely because the governing body is not properly constituted in accordance with these **[regulations]**Regulations.

(2) Where a governing body is not properly constituted in accordance with these **[regulations]**Regulations, the Member of the Executive Council **[shall]**must give the governing body **[six months']**90 days' notice to rectify the defect in its composition.

(3) If, after the expiry of the notice period contemplated in sub-regulation (2), the governing body is still not properly constituted in accordance with these **[regulations]**Regulations, until it is properly constituted, no acts which it performs **[shall be]**is valid."

#### **Amendment of regulation 12 of Regulations**

9. Regulation 12 of the Regulations is hereby amended—

(a) by the substitution for sub-regulation (1) of the following sub-regulation:

"(1) Subject to these **[regulations]**Regulations, a member other than a learner member may hold office for a period not exceeding three years."

(b) by the addition of the following sub-regulation:

"(4) Despite sub-regulations (1) or (2), a member holds office until a new governing body is constituted after the expiry of the term of office of the member."

#### **Amendment of regulation 13 of Regulations**

10. Regulation 13 of the Regulations is hereby amended—

(a) by the substitution in sub-regulation (2) for subparagraph (i) of paragraph (a) of the following subparagraph:

"(i) informed the governing body and the member concerned of his or her intention, with written reasons, so to act **[and the reasons]** within seven working days;"

(b) by the substitution in paragraph (b) of sub-regulation (2) of the word "subsection" for the word "sub-regulation".

(c) by the substitution in sub-regulation (7) for paragraphs (a) and (b) of the following paragraphs, respectively:

"(a) not be **[re-elected into]**elected to any governing body **[for the current term of office during which he or she was removed]**within two years of the removal from office; and

(b) only stand for elections **[in future governing body elections after obtaining permission from]**after two years has lapsed, subject to the approval of the Head of Department."



**Amendment of regulation 15 of Regulations**

11. Regulation 15 of the Regulations is hereby amended—

- (a) by the substitution in sub-regulation (1) for paragraph (b) of the following paragraph:
- "(b) in the office of a parent member, such vacancy **[shall]must** be filled **[at the discretion of the governing body, either]** in accordance with an election in terms of these **[regulations]Regulations** or by co-option: Provided that the total number of parent members co-opted in terms of this paragraph may not exceed 40% of the total number of parent members of the governing body."; and
- (b) by the substitution for sub-regulations (1D) and (1E) of the following sub-regulations, respectively:
- "(1D) The District Director must appoint **[an election officer for each by-election]a district electoral officer for the term of office of a governing body to manage election processes.**
- (1E) A member co-opted in terms of sub-regulation (1B) **[shall cease]ceases** to be a member of a governing body when the vacancy is filled in terms of sub-regulation (1C) or at the end of 90 days, whichever comes first."; and
- (c) by the substitution for sub-regulation (2) of the following sub-regulation:
- "(2) A member co-opted in terms of sub-regulation (1)(b) or sub-regulation (1B) **[shall have]has** voting rights."
- (d) by the substitution in sub-regulation (3) for the words following immediately after paragraph (b) of the following words:
- "[shall remain]remains** a member for the unexpired term of office of his or her predecessor: Provided that he or she is still eligible to remain in office in terms of regulation 16."

**Amendment of regulation 16 of Regulations**

12. Regulation 16 of the Regulations is hereby amended—

- (a) by the substitution for sub-regulations (1) and (2) of the following sub-regulations, respectively:
- "(1) A parent member **[shall]must** be a parent of a learner officially enrolled at the school as reflected in the admission register of the school; and **[shall]must** not be employed at the school.
- (2) A parent member who is eligible under sub-regulation (1) at the time of his or her election to the governing body **[shall cease]ceases** to be eligible to remain a member if the learner in respect of whom he or she qualifies as a parent member ceases to be officially enrolled at the school during the term of office for which the parent member was elected.";
- (b) by the substitution in sub-regulation (8A) for the words preceding paragraph (a) of the following words:
- "(8A)A person [shall not be]is not** eligible to be a member if **[he or she?]**—"; and
- (c) by the addition of the following paragraph:
- "(h) is an official of the Department with direct supervisory responsibility in the school where he or she is a parent."**



### Substitution of regulation 18 of Regulations

13. The following regulation is hereby substituted for regulation 18 of the Regulations:

"The Member of the Executive Council may, by notice in the **[Provincial]Provincial Gazette**, establish guidelines and minimum requirements for the establishment, election and functions of Representative Councils of Learners."

### Amendment of regulation 19 of Regulations

14. Regulation 19 of the Regulations is hereby amended—

- (a) by the substitution for sub-regulation (1) of the following sub-regulation:  
 "(1) The District Director **[shall]must** appoint a **[District Electoral Officer]district electoral officer**, **who shall be an officer of the Department,** to coordinate all electoral activities in a district for the term of office of the governing bodies."
- (b) by the substitution for sub-regulation (2) of the following sub-regulation:  
 "(2) The District Director **[shall]must** appoint one, or more persons to act as **[an election]school electoral** officer for the electoral procedures at a particular school for the term of office of the governing body."
- (c) by the substitution for sub-regulation (3) of the following sub-regulation:  
 "(3) An **[election]electoral** officer **[shall]must** be an officer of the Department **[, a parent or an education]or an educator.**"; and
- (d) by the addition of the following sub-regulations, respectively:  
 "(7) The Head of Department must appoint a provincial electoral officer to coordinate all electoral activities in the province for the term of office of the governing bodies.  
 "(8) A person appointed as electoral officer may not delegate this responsibility to any other person."

### Amendment of regulation 19A of Regulations

15. Regulation 19A of the Regulations is hereby amended—

- (a) by the insertion before the word "The" of the number "(1)" to make the provision thereof "sub-regulation (1)".
- (b) by the substitution for the provision of the following provision:  
 "(1) The election process **[may]must** be monitored by election officials nominated by the Head of Department or an official delegated by the Head of Department."
- (c) by the addition of the following sub-regulations, respectively:  
 "(2) Officials appointed or delegated by the Head of Department—  
 (a) must monitor all the aspects of the election process;  
 (b) have access to all the information relating to the election process;  
 (c) have the authority to guide, where necessary; and  
 (d) must compile monitoring reports.  
 (3) External observers must be accredited by the Head of Department and may not interfere with the election process.  
 (4) Accredited external observer must have access to the election system and sign a declaration of confidentiality.

(5) One external observer per organisation, association or institution is permitted to be an observer at a school."

### **Insertion of regulation 19C into Regulations**

16. The following regulation is hereby inserted after regulation 19B of the Regulations:

#### **"19C Modes of elections**

(1) The Head of Department must determine the mode of election for schools per each electoral cycle.

(2) The modes of elections to be determined by Head of Department are—

(a) Ordinary elections;

(b) Full day elections; or

(c) e-Elections.

(3) (a) Ordinary elections occur when the nominations and elections take place on a specific day within a specified time period and it takes place as follows:

(i) verification of eligible voters on the voters roll;

(ii) opening and closing of the nomination meeting;

(iii) ensure 15% quorum of parents on the voters roll for the poll meeting to start;

(ii) handing out of stamped ballot papers containing the names of nominated candidates;

(iii) marking of ballot papers by parents secretly according to the expected number of parents to be elected;

(iv) placing the folded ballot paper in a sealed ballot box or container provided for this purpose; and

(v) closing the poll meeting and counting commences.

(b) Full day elections occur when voters physically come to the venue to cast their votes at any time within the allocated hours of the day without any meeting;

(c) Nomination for the full day election takes place prior to the election day which is not more than seven days and not less than three days prior elections day;

(d) The following takes place on the full day elections—

(i) verification of eligible voters on the voters roll;

(ii) handing out of stamped ballot papers containing the names of nominated candidates;

(iii) marking of ballot papers by parents secretly according to the expected number of parents to be elected; and

(iv) placing the folded ballot paper in a sealed ballot box or container provided for this purpose.

(e) Counting can only commence after it has been confirmed that the 15% quorum of votes have been cast.

(4) (a) In instances where the Head of Department determines that the mode of elections must be e-elections:

(i) schools are required to use the provincial online election system provided by the Department; and

(ii) the schools must inform parents about the online election system that will be used.

- (b) The Department must provide the provincial online election system to be utilised by all schools.
  - (c) Voters' roll will be uploaded on the provincial online election system for parents to register prior to nominations and elections.
  - (d) Nomination is similar to the nomination procedures followed in full day elections in terms of regulation 19C(3), which takes place online.
  - (e) The completed nominations must be lodged with the electoral officer not more than seven days and not less than three days prior to the elections day.
  - (f) Parents will receive log on details with unique one-time pin to join elections.
  - (g) Online ballot paper will be made available to parents to cast their votes for the required number of parents to be voted for.
  - (h) The system determines the 15% quorum of votes that have been cast to determine the start of counting of votes, calculate and provide results once the election time has elapsed.
  - (i) The electoral officer must use all the available checks and balances to verify the authenticity of results and sign them off."
- (5) All election modes must comply with the 15% quorum requirement.
- (6) Failure to attain the required quorum, the school electoral officer will reschedule the poll and must not require a quorum."

#### **Amendment of regulation 20 of Regulations**

17. Regulation 20 of the Regulations is hereby amended by the substitution in sub-regulation (3) for paragraph (b) of the following paragraph:

- "(b) [post a copy of the notice to the parents of every learner at the school]use any standard form of communication used by the school to communicate the notice to the parents of every learner at school."

#### **Amendment of regulation 21 of Regulations**

18. Regulation 21 of the Regulations is hereby amended—

- (a) by the substitution for sub-regulations (1) and (2) of the following sub-regulations, respectively:

**"[(1) The Principal shall make available to the school election officer a voters' roll for the purposes of exercising control at the nomination meeting.**

**(2) The election officer shall ensure that the voters roll is closed 24 hours prior to the nomination meeting]**

(1) A school must update the voter's roll as determined by the Head of Department prior to the commencement of the elections.

(2) The provisional voters' roll must be signed off by the principal on the last day of the month preceding the elections."; and

- (b) by the addition of the following sub-regulations, respectively:

(3) The election officer must ensure that the voters roll is closed 24 hours prior to the nomination meeting.

(4) The principal must make available to the school election officer a voters' roll for the purposes of exercising control at the nomination meeting."

#### **Amendment of regulation 23 of Regulations**

19. Regulation 23 of the Regulations is hereby amended—

- (a) by the substitution in sub-regulation (10) for paragraph (b) of the following paragraph:

"(b) the election officer **[shall]must** provide the principal with **[sufficient copies]a copy** of a notice which sets out the date, time and place of the second poll meeting;"

- (b) by the substitution in sub-regulation (10) for paragraph (d) of the following paragraph:

"(d) at the second poll meeting there **[shall]must** be no quorum requirement and the poll for parent members **[shall]must** proceed according to the provisions of sub-regulations (3) to (9)."; and

- (c) by the addition of the following sub-regulations, respectively:

"(11) Parents must bring their valid identity documents, passport or other legally accepted form of identification to the nomination and election meetings.

"(12) The date of elections signed off by the principal in consultation with the district electoral officer may be changed, subject to the approval of the provincial electoral officer."

#### **Amendment of regulation 23A of Regulations**

20. Regulation 23A of the Regulations is hereby amended—

- (a) by the substitution in sub-regulation (4) for paragraph (b) of the following paragraph:

"(b) nominations and polling must take place in the manner provided for in **[Regulations]regulations** 22 and 23;"

- (b) by the substitution in sub-regulation (5) for the words preceding paragraph (a) of the following words:

"(5) For the purposes of this **[Regulation]regulation**—".

#### **Amendment to regulation 24 of Regulations**

21. Regulation 24 of the Regulations is hereby amended—

- (a) by the substitution for paragraphs (c) and (d) of the following paragraphs, respectively:

"(c) the **[District Electoral Officer shall]district electoral officer must** ensure that—

(i) each elected member is notified in writing of his or her election; and

(ii) the principal and the District Director are notified in writing of the names of the elected members;"

- (b) by substitution for paragraph (d) of the following paragraph:

"(d) [the District Electoral Officer shall ensure that the principal and the District Director are notified in writing of the names of elected members]in protecting the best interests of learners.

the Head of Department may vet elected members at any stage during their term of office.

- (c) by the addition of the following paragraphs, respectively:
- (e) where the member fails the vetting process, the provisions of regulation 13 of these Regulations applies; and
  - (f) any vacancy created as a result of paragraph (e) above must be filled in accordance with regulation 15 of these Regulations."

#### **Amendment to regulation 25 of Regulations**

22. Regulation 25 of the Regulations is hereby amended by the substitution for sub-regulation (4) of the following sub-regulation:

"(4) The provisions of regulations 21 to 24 of these **[regulations shall apply *mutatis mutandis*]**Regulations apply with the necessary changes required by the context to the election of educator members, and in such application a reference to a parent **[shall]must** be construed as a reference to an educator member, and a reference to a parent member **[shall]must** be construed as a reference to an educator member."

#### **Amendment to regulation 26 of Regulations**

23. Regulation 26 of the Regulations is hereby amended by the substitution for sub-regulation (5) of the following sub-regulation:
