Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board (*"the Board"*) received applications for Site Operator Licences, as listed below.

A Site Operator Licence shall authorise, subject to any conditions which the Board may impose, the keeping and exposing for play in or on the licensed premises or part of such premises, as specified in the Route Operator licence.
