

GENERAL NOTICE 221 OF 2013**NOTICE OF DRAFT SCHEME
INTERIM GREATER GIYANI LAND USE MANAGEMENT SCHEME, 2009**

The Greater Giyani Local Municipality hereby gives notice in terms of Section 28 (1) (a) read in conjunction with Section 18 of the Town-planning and Townships Ordinance, 1986 (Ordinance 15 of 1986), that a draft town-planning scheme to be known as Amendment Scheme 22 has been prepared by it.. This scheme is an amendment scheme and contains the following proposal:

The rezoning of part of the farm Greater Giyani 891LT, roughly 50ha in extent, situated between Giyani BA and Unit D, from "Agriculture" to "Business 1".

The draft scheme will lie for inspection during normal office hours at the office of the Municipal Manager, Civic Centre, Giyani, for a period of 28 days from 7 June 2013.

Objections to or representations in respect of the scheme must be lodged with or made in writing to the Municipal Manager, Private X9559, Giyani 0826, within a period of 28 days from 7 June 2013.
